1. Patan Municipality has received a grant from GoN towards the cost of following bids and intends to apply part of the funds to cover eligible payments under the Contract for NCB/PTNMUN/W-09/077/78. Bidding is open to all eligible Nepalese Bidders.

2. Patan Municipality invites electronic bids from eligible bidders for the Construction of Patan Primary Hospital (15 bed), Patan, Baitadi under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

3. Only eligible bidders with the following key qualifications should participate in this bidding.

At least 1(one) 2 -StoreyFramed Building construction Project within the last ten(10) year with the value of at least NRs.15,00,00,000.(without VAT) that have been successfully or are substaintly completed.RCC Works at least M20 750M3 ,M25 1350 M3, Reinforcement at least 350 Mt.

4. Bidders, submitting their bid electronically, should deposit the cost of bidding document of a non-refundable fee of Rs.10,000 in account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Electronic bids must be submitted to the office Patan Municipality through PPMO website www.bolpatra.gov.np/egp on or before 12:00 noon on 2078-02-18. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2078-02-18 at the office of Patan Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of Rs.50,00,000, which shall be valid for 30 days beyond the validity period of the bid .
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Office of Patan Municipality, Patan, Baitadi reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to award contract.
10. If any provision of bid document is inconsistent with Public Procurement Act (PPA), 2063 and Public Procurement Regulations (PPR), 2064, the provision of bid document shall be void to the extent of such inconsistency and the provision of PPA and PPR prevail.
